

President Gale Cochran-Smith opened the meeting.

The Treasurer's report showed \$1,398.29.

Gale requested information on shows/workshops, and provided information on other items:

- The Justin Building in Nocona will be refurbished. There has been mention of having an open air art show in the fall. More information to follow.

Gale turned it over to Larry to announce upcoming programs, and to introduce our guest speaker, Linda McCarley, an Art Psychotherapist.

Larry announced the upcoming programs.

- May Photography with Willetta Crow.
- June Field Trip
- July CTAA Art Show
- August Debbie Malone
- September Larry's studio in Nocona.
- Oct/Nov Scheduling a national photographer who does shows throughout the country.

Larry then introduced Linda McCarley, an Art Psychotherapist. Linda is a Licensed Social worker with a MA in Social Work from UTA. She is mainly interested in the experience of the "art maker," and what it means to them. She also trained at the U of IL, and she organized and ran the Art Therapy Institute in Dallas for 10 years, because there was nothing in TX at the time. Linda walked through the history of uncovering the unconscious mind - we can draw more purely what our experiences have been instead of being able to talk around issues. Linda works with children and their families, and trains parents to have special art training at home with their children. She uses the whole range of art for therapy – she also finds it restful to paint from her heart.

Linda's favored pioneers in the field of Art Therapy were, Edith Kramer, who in Austria worked with children who had witnessed war. In NY, Edith created an approach called "art as therapy." Margaret Nomberg spoke to the value and beauty of art that gives one the opportunity for insight – Art Psychotherapy.

When asked if Art Therapy was being taught in TX, she responded no. Linda herself is an art psychotherapist, and will soon teach expressive art therapy at SMU. The goal is to figure out individual problems, come up with a treatment plan, and figure out how to meet that problem with art. People will draw/paint their trauma. She passed around books that showed children's drawings of war, and one of the Oklahoma City bombing. The goal is to heal. We then had an exercise in art therapy that gave us a better understanding of the therapy. Very enjoyable and informative! 


