#### CTAA Meeting Minutes March 8, 2018



President Gale Cochran-Smith opened the meeting.

- The Treasurer's report showed \$743.29 + \$35 in dues tonight, for a total of \$778.29. Gale turned the meeting over to Larry, who went through upcoming presentations, and then welcomed Kathy Stout, the presenter for tonight.
- We will have the 2nd annual Art Show and Sale, on anything in any era related to Oil and Gas, from June 30, 2018 to August 17, 2018. The show will be held at the Tales and Trails Museum in Nocona. The cost will be \$35 per entry with \$25 per entry for members. Gale still looking for volunteers to help with organizing. Deadline for entries will be June 1, 2018.
- Soon Warren's workshop will be July 18, 19 & 20 in Nocona at the Fellowship Hall at the Central Christian Church. The cost will be \$200, and \$50 deposits will be taken beginning April 1, 2018.

Larry then introduced Kathy Stout, tonight's presenter. Kathy lives in Nocona, and Larry and Kathy have known one since the 1970s. Kathy is a Christian artist, and tonight's demonstration will be Kathy painting the face of Jesus. As she painted, she talked about her career, and the colors and brushes she uses in her paintings. She calls her paintings abstract, and uses 9x12 canvas boards, that take 3 days to dry. Kathy stopped periodically and discussed her colors and why she does what she does with her work. She mentioned that Dalhart Windberg was her all-time favorite artist. He is an official artist of Texas, and lives and paints in Georgetown. Kathy uses a badger hair brush for some of her detail work, and she said the hardest part of painting is signing your name. She does one part of each letter at a time – it seems to work. She brought two other portraits of Jesus with her as demonstrations of her artwork – they were beautiful. Her finished portrait of Jesus was also beautiful, and was purchased on the spot by one of the members.

This Year's Juror: Beverly Boren, Trophy Club, TX




